X. Sales and Tax Payment Update:

To date, \$5 million has been returned to the state: \$2 million for regulatory assessment, \$2 million for the gambling pact and \$1 million for responsible gambling. He noted that we continue to see period-over-period growth in sales.

XI. Sports Betting Retail Development Update:

Mr. Walter noted the work on XL Center continues and the recent announcement of Arooga's Sports Bar in Shelton. He indicated that status regarding these locations as well as a Bridgeport location would be discussed in more detail during Executive Session.

XII. Executive Session:

At 10:13 a.m. on a motion by Mr. Heckman, seconded by Mr. Meehan, and unanimously approved, the Committee moved to Executive Session to discuss the following:

- b. iLottery Update

All staff members attended Executive Session.
