#### I. Welcome:

Chair Simmelkjaer welcomed Committee members and thanked them for their attendance. He called the meeting to order at 10:03 a.m.

#### II. Approval of May 12, 2022 Executive Committee Meeting Minutes:

On a motion by Ms. Morton and seconded by Mr. Blanchette, the minutes from the May 12, 2022 Executive Committee Meeting were approved.

#### III. Update on Sales and Profits:

Mr. Smith provided a high level recap of Sales and for the year ended June 30, 2022 noting that sales were \$1.451 billion, \$6 million below budget and that \$401 million was returned to the general fund, \$16 million ahead of budget.

#### IV. Update on Company-wide Ethics Training:

Ms. Durso discussed company-wide ethics training, noting that the full Board had training at the end of last year and that there would be an all-employee training this fall.

### V. <u>Update on Lottery Vendor Diversification</u>:

Mr. Smith provided an update with regard to vendor diversification and mentioned that the Lottery recently had meetings with Minority Construction Council (MCC) and Society of

Human Engagement & Business Alignment (SHEBA) to help get more interest, broader scope and better yield in diversified communities.
